

## Terms of Use

TRAINOSE S.A. (hereby the “Company”) has created the website [www.trainose.gr](http://www.trainose.gr) (hereby “the website”) and wishes to provide its services in accordance with the following Terms of Use. The visitor/user of the pages of the website shall read carefully the following terms and proceed to the visit/use of the pages/services of the website only if he/she accepts them as a whole.

All services already provided, as well as any further services that may be added in the website from time to time are subject to the present Terms of Use, unless provided otherwise in writing.

- 1. LIABILITY LIMITATION.** The Company endeavors to ensure that all information and content of the website are correct and complete. However, taking into account the nature and the volume of information on the internet, the Company shall not be liable under any circumstances, including negligence, for any kind of damages incurred on the visitor/user of the webpages, services, choices and information of the website to which he./she proceeds to by his own initiative.
